SUMMARY:

The basic function of the Laborer is to install, repair, and rehabilitate sewer and water lines.

AUTHORITY AND REPORTING RELATIONSHIPS:

The Laborer at Southeast Pipe Survey, Inc. is hired by, and reports to the Crew Leader.

The Laborer has the authority to operate company equipment as necessary to accomplish his tasks.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

The Laborer's responsibilities include but are not limited to:

- Present a professional image of Southeast Pipe Survey, Inc. to customers, fellow employees, and the general public.
- · Assure that the work is of top quality in every respect.

THE LABORER'S DUTIES INCLUDE BUT ARE NOT LIMITED TO:

- Be sure the truck is fueled up.
- Wash the vehicles and equipment as required to keep them clean and in good repair.
- Know the location of all tools to prevent loss or theft.
- Get all necessary supplies for Monday when the crew is at the office on Friday.
- Know and adhere to all company policies and procedures.
- Know and adhere to appropriate OHSA regulations.
- Review this job description at least annually and make recommendations for improvement to the Crew Leader.
- Any other duties that the Foreman/Crew Leader may request from time to time.

MEASURES OF PERFORMANCE:

The Laborer will be deemed to be performing satisfactorily when;

- Work is excellent quality.
- Demonstrates knowledge of all construction activities without repetitive or daily instructions.
- · Works will with others.
- Has achieved the over all satisfaction of the Field Supervisor /Crew Leader.

QUALIFICATION REQUIREMENTS:
